DELIVERY AND LIABILITY LIMITATIONS

The LAB will analyze samples provided by CUSTOMER as requested by CUSTOMER in accordance with the procedures documented in the Quality Assurance Plan (QAP). Samples are retained for 15 days. If additional time is desired, then a written request is required and an additional monthly fee will apply. This price quote is only valid for one year after initial quote date.

The LAB will treat all information regarding work performed for CUSTOMER as proprietary and confidential. No CUSTOMER information will be released to third persons without the written request of the CUSTOMER.
